MSC Committee Leaders Poised for New Challenges, Opportunities in 2012

Canonsburg, PA – Marcellus Shale Coalition (MSC) Chairman Dave Spigelmyer today announced the 41 men and women elected by the MSC's Board of Directors to lead the organization's committees and subcommittees in 2012. 75 individuals ran for leadership positions across 20 panels. MSC committees craft and communicate responsible practices for shale gas development in Pennsylvania, Ohio, West Virginia, New York, and Maryland and are comprised of professionals from the MSC's more than 250 member companies.
